

## 2024 MEMBERSHIP LEVELS AND REQUIREMENTS AT SUDDEN PITCH/SWIMMERS, INC.

### 1. Regular Family Membership

- a. Full family privileges (a family is comprised of up to 2 adults and any dependent, unmarried children under the age of 25 that reside at the primary residence)
- b. Full access to pool, tennis, events, clubhouse, clinics, leagues, and lessons for all family members
- c. Annual Dues - \$1260 (Plus \$100 Pitch Bucks)
- d. Community Fee (one time) - \$1900 if paid in full; 2 payments is \$1000 with application and \$1000 on September 1
- e. Stockholder (includes voting rights)

### 2. Individual Adult Membership

- a. One adult member ONLY
- b. Full privileges and access to pool, tennis, events, clubhouse, clinics, leagues, and lessons
- c. Annual Dues - \$790 (Plus \$100 Pitch Bucks)
- d. Community Fee (one time) - \$950
- e. No Stockholder status
- f. **Grandfathered stockholder** - Membership conversion from Regular Family to Individual Adult for someone who paid the full community Fee. They would retain their stockholder status.

### 3. Adult Legacy Membership

- a. One or two adults ONLY (no children)
- b. Full privileges and access to pool, tennis, events, clubhouse, clinics, leagues, and lessons for both adults
- c. Minimum legacy requirements (shown below) must be met
- d. Annual Dues - \$735 (Plus \$100 Pitch Bucks)
- e. Community Fee (one time) - None
- f. Stockholder (includes voting rights)

### 4. Special Membership

- a. One or two adults ONLY (no children)
- b. Access to pool, tennis, events, clubhouse for both adults
- c. No access to clinics or lessons (leagues on a space-available basis)
- d. Twenty (20) visit limit per year
- e. Minimum legacy requirements (shown below) must be met
- f. Annual Dues - \$420 (Plus \$25 Pitch Bucks)
- g. Exempt from cleanup duties
- h. Community Fee (one time) - None
- i. No Stockholder status

### **ADDENDUM - Requirements for Adult Legacy or Special Member**

- a. The requirements for application for Adult Legacy or Special Membership are that the member shall have been a stockholder for a minimum of ten (10) years and either:
  - i. The member's youngest child living at home is 16 or older by January 1st of the current membership year or
  - ii. The member has moved their primary place of residence outside of a twenty-five (25) mile radius of Manchester
- b. Application must be made in writing to the Board of Directors and received prior to the membership due date of the current year
- c. Acceptance will be by a unanimous vote of the Board of Directors in accordance with the bylaws
- d. Members who have been accepted for Special Membership must resign from regular membership, relinquish voting rights, and sign the Special Membership Agreement (for the first year only), returning same to the Board
- e. Members who have been accepted for Adult Legacy will retain their voting rights and Stockholder status
- f. Special Membership eligibility, once having been established, will be a continual status unless application is made for a change or revoked by the Board for misuse
- g. Special Members will be invited to all social functions and have full rights with regard to bringing guests, signing up, and paying as usual
- h. Special Members or Adult Legacy have full use of all the facilities of Swimmers, Inc., subject to limitations set by the Board of Directors. Children of Special Members or Adult Legacy are not members of Swimmers, Inc. Children of Special Members or Adult Legacy may use the pool and tennis facilities as a registered guest in the absence of their parents. However, all other rules and fees for guests shall apply. Special Members or Adult Legacy shall be present when their child or children bring a guest to Swimmers, Inc.
- i. Special Members - Use of the pool and/or tennis courts shall be limited to no more than twenty (20) days per season. Adult Legacy members have NO visit limits
- j. Special Members - Are not entitled to swimming or tennis lessons. Adult Legacy CAN participate in clinics and lessons
- k. Although non-voting members, Special Members are encouraged to actively participate and convey their ideas, concerns, and suggestions to the Board
- l. Special Members - Participation on Swimmers, Inc., tennis leagues is made on a space-available basis. Adult Legacy members have NO restrictions on leagues
